 Transfer of Reserves Funds:- Investigations have been ongoing regarding the savings accounts for reserves currently in NS&I accounts. We have received a proposal from CCLA for an easy access interest bearing account of 1.9582%. This is a daily interest rate and will fluctuate. Fixed rate accounts are available at better rates but no access for 12 months

Approval is required for:-
